Corrigendum cum Addendum

The following changes in the NIT are hereby notified through this Corrigendum for all concerned interested bidders:

- Sl. 1 **Type of Aircraft:**
Instead of Aircraft the type of aircraft must be **Jet Aircraft**.
- Sl. 2 **Station:**
2.1 The Aircraft will be stationed in Guwahati and fly to any destination as per the direction of ATDC (within 48 hours of notice).
2.2 In the case of rental for a specific journey, the Operator has to ensure to provide the Aircraft from the nearest destination for flying the said journey as per the direction of ATDC (within a 48 hour notice)
- Sl. 3 **Base:**
3.2 DGCA letter to be provided in case of delay. *(Added)*
- Sl. 4 **Substitute aircraft:**
4.2 The substitute Aircraft so provided shall also be of the same class. *(Read only)*
- Sl. 5 **Scheduled inspection:**
5.1 4 (four) days per month will be permitted for schedule inspection & maintenance of aircraft.
- Sl. 6 **Tenure (duration) of lease:**
7.1 The minimum guaranteed flying time will be 30 hours per month.
- Sl. 7 **Eligibility criteria:**
9.1.5 The age of the aircraft should not be more than 10 years old and should not have completed more than 3000 flying hours. This applies to the both the aircraft and its substitute.
- Sl. 8 **Annexure III**
The clause relating to accident free record for last 1 year is waived but the bidder has to maintain all the security measures as per norms.
- Sl. 9 **Added 1: Consortium:**
Consortium may be permitted between 2 (two) parties. The Consortium company should have NSOP license.
- Sl. 10 **Added 2: Security of Aircraft:**
Security measures of the aircraft, wherever it is required, will be arranged with the help of concerned District Administration / local authorities during night halt outside Guwahati where there is no airport.
- Sl. 11 **Added 3: Crew accommodation:**
Crew accommodation will be provided with the help of District Administration / local authorities during night halt outside Guwahati only where hotel accommodation is not available. Necessary payment etc. have to be borne by the operator.
