“CORRIGENDUM”

Reference EOI Notice issued vide this office of undersigned on 23.06.2016 and subsequence discussion held in the pre-bid meeting held on 15.7.2016 towards the projects viz. **“Conceptualising and running of Souvenir Shops and Information Kiosk of Assam Tourism on a turnkey basis”**, the following changes in the EOI Notice are hereby notified through this Corrigendum for all concerned interested bidders.

1. Clause 4.4 may be read as “The agency must have previous experience of signage Production & Installation with Govt. organizations / Public Sector Undertaking / Private Corporate Sector.”
2. Following documents are required to be submitted along with the tender.
 - Pan Card of the firms
 - Trade Licence
 - Service Tax and VAT registration certificate
 - All documents in support of credentials referred under clause 8 Qualifying Format of EOI.
 - The concept design sought under clause 5 & 7.2.1 of EOI Notice to be submitted for various types of innovative designs preferably considering one tourist destination in mind.
3. In support of financial turnover of last 3 years, the bidders may submit provisional balance sheet of FY 2015-16, in case the audited balance sheet is not available for the FY 2015-16. Alternatively balance sheet of FY 2012-13 may be submitted in lieu of FY 2015-16.
4. Under financial bid sought under clause 8 Qualifying Format, the bidders are expected to submit revenue sharing model for each design submitted in concept design.
5. Concept design submitted by the bidder will carry proportionate marks in the final selections of bidder with envisaged due process at RFP stage.
6. Bidders may submit the bid as a consortium not exceeding 2 entities. For the purpose of fulfilment of eligibility criteria the profile of lead member will be considered. The necessary MOU with the consortium partner to be submitted along with application.
