2.Bid Security : The Bidder shall furnish, as part of his Bid, a Bid Security amounting to Rs. 12,000.00 in the form of Demand draft / cheque duly pledge in favour of Managing Director, Assam Tourism Development Corporation Ltd. validity with 30 days from the date of Bid submission. The EMD of the unsuccessful bidders will be returned within 07 days of opening the bid.

3.Bid processing fee: Rs. 500.00 (nonrefundable) in the form of Demand Draft / Banker Cheque pledge /cash in favour of Managing Director, Assam Tourism Development Corporation Ltd and furnish the same with application.

4. Documents to be enclosed with Bid : Documents mentioned in **Annexure 1.**

5. Sealing and Marking of Bid:

The Bidder shall seal both the Bid copies i.e. Technical & Financial in separate envelopes, duly marking the envelopes as “Technical Part of Bid” & “Financial Part of Bid”. These two envelopes (called as inner envelopes) shall then be put inside one outer envelope.

i) **The Contents of Technical Part of Bid** – Bid Security Rs 12,000.00 and eligibility criteria (Supporting documents) & sealed and signed in **Annexure 1**, Conceptualization and 3D model design of the Assam Stall

ii) **Contents of Financial Part of Bid** - Form of Financial Part of Bid to be filled & signed. The financial proposal should contain the cost inclusive of all taxes. **Annexure-II**.

6. Submission & Opening of Bid: Sealed Bids must be delivered to the Managing Director, Assam Tourism Development Corporation Ltd., A.K. Azad Road, Paltan Bazar, Guwahati-8, on or before 14:00 hrs. on **26.12.2016** and the Technical Part of Bids will be opened on the same day at 14.30 hrs., in the presence of the Bidders or their authorized representatives, who wish to attend. If the office happens to be closed on the date of receipt of the Bids as specified, the Bids will be received and opened on the next working date at the same time & venue. The date & time for opening of Financial Part of Bid will be intimated to the technically qualified Bidder in time.

ELIGIBILITY CRITERIA

1. The Agency must be engaged full time in Event management, Branding, media & PR activities only.
2. Must have successfully organized similar events for any Govt / P.S.U or private companies at least for 3 events in the past 2 years.
3. Must have regular designer, creative team, and technical work force in their payroll.

SELECTION CRITERIA

1. The technical bids will be opened first and shall be scrutinized to verify the eligibility criteria. Those who fulfill all the criteria will be shortlisted.
2. The Financial bids of those agencies who fulfill the eligibility criteria and shortlisted will be opened for final selection. 70% weightage shall be given on technical bids and 30 % weightage shall be given on financial bids.
3. The selection process shall be QCBS (Quality & Cost based selection).

EVALUATION OF TECHNICAL BID

- a) Conceptualization and 3D design of the pavilion/stall - 45Pts
- b) Past experience of similar National / International Pavilion in last 2 years. -15 Pts (10 pts per year)
National - 5 pts
International -10 pts
- c) Creative designs for branding -10 pts

Minimumm 60 points should be scored for opening of financial bid. The above-mentioned documents have to arrange in sequence.
