**Brief Summary of the Project :-**

The Assam Tourism Development Corporation Ltd. proposes to assign management contract for running of the Wayside Amenity Centre at Gohpur. The project is situated at Gohpur by the side of NH-52 towards Lakhimpur and consist of (i) Restaurant Block, (ii) Kitchen, (iii) Toilet Block with a total plinth area of 362.20 sq.m. with all modern amenities.

Bids are invited from interested firm / individual having experience in running Hotel, restaurant, guest house with sound financial conditions for its management for a period of 3 (three) years. The selected party shall be granted authority to manage and run the project against payment of contract money to Assam Tourism Development Corporation Ltd. It should be noted that selection of a party would be based strictly on their suitability and adequacy to run the project as per evaluation of bids.
