**12) Bidders Minimum Qualification Criteria:**

- i. Experience of having successfully completed similar works during last 7 years ending last day of month previous to the one in which Bids are invited should be either of the following-
  - a) Three similar completed works costing not less than the amount equal to 40% of the Bid value.

**Or**

  - b) Two similar completed works costing not less than the amount equal to 50% of the Bid value.

**Or**

  - c) One similar completed work costing not less than the amount equal to 80% of the Bid value.
- ii. Bidders must submit work order and completion certificate.
- iii. Average Annual financial turnover during the last 3 years, ending 31<sup>st</sup> March of the previous financial year, should be not least 30% of the Bid value.

**iv.** Bidders must submit Audited Balance sheet in support of his financial credentials, for the last 5 (five) years.
