If the office happens to be closed on the date of receipt of the bids as specified, the bids will be received and opened on the next working day at the same time & venue.

iii) Annual turnover of the respective Bidder must not be less **Rs. 2,14,46,288.00** in any year from the last five years.

iv) Bidders must submit Audited Balance sheet in support of his financial credentials, for the last 5(five) years along with application.
