2. Contractors / Firms / Private Limited Company registered with ATDC Ltd. and Assam P.W.D.(Building) as a class 1A category with up-to-date registration certificate, having experience in similar nature of works are eligible to Bid.

(i) Attested copy of up to date Registration Certificate of ATDC Ltd or A.P.W.D (B)(ii) VAT Regd. Certificate and Up to date VAT Clearance Certificate, (iii) Copy of PAN Card, (iv) Deed & Power of Attorney (in case of Firms), (v) MOU & Power of Attorney (in case of Private Ltd. Company), (vi) Completion Certificate of similar nature of work along with work order, (vii) Annual Turn Over Certificate from C.A., (viii) Balance Sheet, (ix) valid license for labour, (x) valid license for Anti termite work, (xi) valid license for electrical work (or tie-up arrangement with such license holder for carrying out the Anti termite work and electrical work) are to be furnished along with the application seeking issue of Bid Document for pre-qualification of the applicant. Other things being equal, ATDC Registered Contractors may be considered for preference over other as per merit (All documents should be attested & clear).

4. A pre- bid meeting will be held on 24.12.2010 at 12.00 hours at the office of the Managing Director, ATDC Ltd., A.K. Azad Road, Paltanbazar, Guwahati-8, to clarify the issues and to answer questions on any matter that may be raised.

5. Bid must be accompanied by Bid Security of the amount specified for the work in above table, drawn in favour of Managing Director, ATDC Ltd., A.K. Azad Road, Paltanbazar, Guwahati – 8 in the form of NSC/KVP/FDR/Call Deposit or in Cash. Bid security will have to be valid for 45 days beyond the validity of the Bid(i.e. 180 days + 45 days = 225 days from the date of submission of Bid).

6. Sealed Bid must be delivered to the Managing Director, Assam Tourism Development Corporation Ltd., A.K. Azad Road, Paltanbazar, Guwahati – 8, on or before **14.00** hours on **28.12.2010** and the Technical Bid will be **opened on the same day at 14.30 hours**, in the presence of the Bidders or their authorized representatives, who wish to attend. If the office happens to be closed on the date of receipt of the Bid as specified, the Bid will be received and opened on the next working day at the same time & venue (All qualified Bidders are requested to deliver their seal Bid before 14.00 hrs of **28.12.2010**).

7. Price Bid of qualified Bidder of Technical Bid will be opened on **30.12.2010** at 14.30 hours in the presence of the Bidders or their authorized representatives, who wish to attend. If the office happens to be closed on the date of opening of the Price Bid as specified, the Bid will be opened on the next working day at the same time & venue.

8. Prospective Bidders should inspect the site and details of the Project at any suitable date before submission of Bid with due permission of the Managing Director, Assam Tourism Development Corporation Ltd.

9. Bidders Minimum Qualification Criteria:

i) The Bidders should have completed similar nature of single work with value not less than **Rs.41,45,668.00** under Government/ Public Sector Organization only in any year from the last 5(Five) years.

N.B.- (i) Bidders must submit attested copy of work order and work completion certificate along with application.

ii) Annual turnover of the respective Tenderer must not be less than **Rs. 94,21,973.00** only in any one year for the last five years.

N.B.- Bidders must submit attested audited Balance sheet in support of his financial credentials, for the last 5(five) years along with the application.

10. Bidders should quote rates considering the latest Govt. order / circular / notification on VAT etc.

11. The Managing Director, ATDC Ltd., reserves the rights of issuing of Bid document or outright rejection of any application of Bidders.
