Invitation of
Expression of Interest (EOI)

Assam Tourism is going to install a statue of **Bir Lachit Borphokan** on the river **Brahmaputra** near Urbashi Island, Guwahati.

Accordingly, **Expression of Interest** are hereby invited by the undersigned for construction of two pedestals for installation of the **Statue of Lachit Borphokan**. Organization / agencies possessing experience and expertise in construction of well foundations in large river with multiple under current as in the river Brahmaputra are eligible to apply for the work.

The entire works relating to survey, drawing and designs, supply, installation and commissioning will be on turnkey basis as per scope of work mentioned below :-

- 1) All statutory permission from local authorities as may be required.
- 2) Permission from National Waterways Authority as may be required.
- 3) Environmental clearance from Ministry of Forest & Environment, Govt. of India.
- 4) Geotechnical investigation of river bed etc. as may be required.
- 5) Detailed survey works including hydrographic survey.
- 6) Transportation of men & material to the site of work.
- 7) Design & Drawing of well foundation with two RCC pedestal of sizes 9.15mx7.62 m & 15.00mx7.62m over the wells respectively.
- 8) Construction of foundation and pedestal for installation of the statue.
- 9) Installation of necessary pedestal 9.15m x 7.62 m to support and erect a bronze statue of Bir Lachit Borphokan of approx. 15.00 m height with weight of 5.00 ton. The other pedestal of sizes 15.00m x 7.62 m will support fibre made statue of 9 (nine) of Armies and 2 of cannons with approx. weight of 3.00 ton.
- 10) Transportation & erection of statue on the top of the pedestal from place of construction.
- 11) Illumination of the statue.
- 12) Any other relevant items of work.
- 13) The works to be completed within the 31st December 2010.
- 14) 2% Bid security are required to be deposited on the basis of cost estimates prepared by the party for the entire work.
- 15) All the above requirements are to be submitted within 20th June 2010 in the office of the Managing Director, Assam Tourism Development Corporation Ltd at the time of submission of EOI.

The undersigned reserves the right to reject all the EOIs without assigning any reason thereof and also to take such other steps as may be considered necessary in the interest of execution of the project.
