4). Bids must be accompanied by Bid security of the amount specified for the work in above table, drawn in favour of Managing Director, ATDC Ltd., A.K. Azad Road, Paltanbazar, Guwahati – 8. Bid security will have to be in any one of the forms as specified in the Bidding document and shall have to be valid for 45 days beyond the validity of the Bid (i.e. 180 days + 45 days = 225 days from the date of submission of Bid).

Azad Road, Paltanbazar, Guwahati – 8, on or before **14.00** hours on **14.02.2011** and the Technical Bids and Price Bids of technically qualified Bidder will be **opened on the same day at 14.30 hours**, in the presence of the Bidders or their authorized representatives, who wish to attend. If the office happens to be closed on the date of receipt of the Bids as specified, the Bids will be received and opened on the next working day at the same time & venue.

**8). Bidders Minimum Qualification Criteria:**

i) The Bidder should have completed similar nature of work with value not less than **Rs.28,79,988.00** only in any one year for the last 5 (five) year.

ii) Bidders must submit Audited Balance sheet in support of his financial credentials, for the last 5(five) years along with the Bids.

iii) Annual turnover of the respective Bidder must not be less than **Rs. 65,45,427.00** only in any one year for the last five years.

**10) Bidders who do not fulfill the requirements need not apply for Bid document.**
